

The GSE Composite Index inched up 0.05 points during the week to 3,195.62 index-points (YTD: +30.76%).

The Ghana Stock Exchange Index closed the week with a single advancer, bringing it to a year-to-date high of +30.76%. Unilever Ghana Plc (UNIL) was the sole gainer, with its share price rising +0.12% to GH¢8.11. As a result, the benchmark composite index closed at 3,195.62 index points, which is the index's best gain since December 2021. The stock market has traded at a year-to-date average daily return of 14.84%.

Furthermore, the financial stock index saw no changes this week and continues at 2,042.09 index points with a year-to-date decrease of -0.51%, as investor sentiment on financial stocks remains poor.

By the end of the week, a total volume of 76,628,897 shares, valued at GH¢99,650,475.19 exchanged hands in eighteen (18) equities. The Ghana Stock Market holds a total market capitalization of GH¢ 74,498.02 million.
